SynDeck IMO Epoxy - Colors & Clear SS5000 is a top-quality amine-cured epoxy coating. It is 100% solids, very low odor, user friendly, and has excellent abrasion resistance. This product cures to a resilient, high-gloss film and is available in an array of colors, as well as clear. It can be applied over deck underlayments and properly prepared existing epoxy coatings, resulting in a new, high gloss finish in one to two coats.

SynDeck IMO Epoxy - Colors & Clear SS5000 is self-leveling, has superior gloss and can be applied at lower temperatures (50°F/10°C) with no blushing. Product is dry for foot traffic overnight.

# Ratings

Material is not readily ignitable and meets low flame spread requirements for primary deck covering and floor covering as specified in IMO FTP Code 2010 (Res. MSC.307(88)) Part 5 of Annex 1. Product meets Part 2 of Annex 1 without further testing by complying with paragraph 2.7 in appendix 4 of Annex 1: Part 5 of the IMO FTP Code 2010 (Res. MSC.307(88)).

- 2. The scope of Type Approval is to comply with MSC.1/Circ.1221 dated 11 December 2006.
- 3. The product is approved for application to any metallic substrate having a thickness higher than 3 mm.
- 4. The thickness of the application should be between 6 and 10 mils and should not exceed 10 mils (0.254 mm) for use as a floor covering from a flammability and smoke generation stand point.
- 5. Two component epoxy to be installed per manufacturer instructions.
- 6. If any adhesive is used other than the one used during testing, then that has to be tested for low flame spread characteristics according to IMO 2010 FTP Code Part 5.

- 1. The Manufacturer has provided a declaration about the control of, or the lack of Asbestos in this product.
