It is designed for use over underlayment and other surfaces where high porosity is a concern.

SynDeck Super Underlayment Sealer SS1259 is ideal for sealing Syndeck underlayments such as: SynDeck Ultra Lightweight Underlayment SS1290FC, SynDeck Ultra Lightweight Terrazzo SS1290FCT and SynDeck 1.5 IMO Underlayment SS1295.

Ratings

Material is not readily ignitable and meets low flame spread requirements for primary deck covering and floor covering as specified in IMO FTP Code 2010 (Res. MSC.307(88)) Part 5 of Annex 1. Product meets Part 2 of Annex 1 without further testing by complying with paragraph 2.7 in appendix 4 of Annex 1: Part 5 of the IMO FTP Code 2010 (Res. MSC.307(88)). Material is deemed not capable of producing excessive quantities of smoke or toxic products.

Service Restrictions

- 4. The thickness of the application shall not exceed 10 mils (0.25 mm) for use as a floor covering from a flammability and smoke generation stand point.
- 5. Two component epoxy to be installed per manufacturer instructions.
- 6. Any adhesive used other than the one used during testing, has to be tested for low flame spread characteristics according to IMO 2010 FTP Code Part 5.
