Description

SynDeck Ultra Lightweight Terrazzo SS1290FCT is a three component, aggregate-filled, 100% solids, amine-cured epoxy flooring product. This product can be applied as an ultra lightweight underlayment to fair and level decks which also provides a decorative surface.

Ratings

Material is not readily ignitable and meets low flame spread requirements for primary deck covering and floor covering as specified in IMO FTP Code 2010 (Res. MSC.307(88)) Part 5 of Annex 1.

Material is not capable of producing excessive quantities of smoke or toxic products for primary deck covering and floor covering per IMO FTP Code 2010 (Res. MSC.307(88)) Part 2 of Annex 1.

Service Restrictions
